### **Course Description**

The course will focus on quantification of microbial growth, metabolite production, and microbially mediated degradation and transformation processes emphasizing the application of these tools to design industrial relevant bioprocesses for pollution control and bioremediation. 3 Credits (Spring)

### **Course Objectives**

The objectives of the course are to

- develop concepts and mathematical tools required to understand and analyze microbial growth, metabolite production and microbially mediated degradation and transformation processes,
- quantify and analyze bioreactor operation and performance through mathematical process modeling and simulation,
- learn about some industrially important bioprocesses used for pollution control and bioremediation,
- construct mathematical process models to simulate operation of these bioprocesses.
